ENVIRONMENTAL AND SOCIAL COMMITMENT PLAN

1. The Ministry of Environment and Forestry (**MoEF**) and the Peatland and Mangrove Restoration Agency (Badan Restorasi Gambut dan Mangrove, **BRGM**) of the Republic of Indonesia will implement the Indonesia Mangroves for Coastal Resilience Project (the **Project**), with the involvement of the Indonesia Environmental Fund (**IEF**), sub-national government agencies at the provincial, district and village levels and third-party service providers, including non-government organizations (**NGOs**), community groups, consultancy firms and contractors. The International Bank for Reconstruction and Development (the World Bank or the **Bank**) has agreed to provide financing for the Project.
2. The MoEF and BRGM through their respective Project Implementation Units (**PIUs**) will implement material measures and actions consistent with the Environmental and Social Standards (**ESSs**). This Environmental and Social Commitment Plan (**ESCP**) sets out material measures and actions, any specific documents or plans, as well as the timing for each of these. These include Environmental and Social Management Framework (**ESMF**) and associated frameworks contained therein, and Stakeholder Engagement Plan (**SEP**).
3. The MoEF and BRGM are responsible for compliance with all requirements of the ESCP even when implementation of specific measures and actions is conducted by sub-national government agencies and third-party service providers referenced in 1. above. The MoEF as the Executing Agency for the project with support from a Project Management Office (**PMO**) will be responsible for the overall coordination and oversight of the implementation of the project's environmental and social management as elaborated in the ESMF, SEP and ESCP.
4. Implementation of the material measures and actions set out in this ESCP will be monitored and reported to the Bank by the MoEF and BRGM as required by the ESCP and the conditions of the legal agreement, and the Bank will monitor and assess progress and completion of the material measures and actions throughout implementation of the Project.
5. As agreed by the Bank and the MoEF and BRGM, this ESCP may be revised from time to time during Project implementation, to reflect adaptive management of Project changes and unforeseen circumstances or in response to assessment of Project performance conducted under the ESCP itself. In such circumstances, MoEF and BRGM will agree to the changes with the Bank and will update the ESCP to reflect such changes. Agreement on changes to the ESCP will be documented through the exchange of letters signed between the Bank and the MoEF and BRGM as applicable will promptly disclose the updated ESCP.
6. Where Project changes, unforeseen circumstances, or Project performance result in changes to the risks and impacts during Project implementation, the MoEF and BRGM shall provide additional funds, if needed, to implement actions and measures to address such risks and impacts, which may include environmental impacts, occupational and community health and safety impacts, land tenure and resource conflicts.
